Designate Your Tax Dollars to Help Students of LHUSD #1

Did you know that if you must file and pay State of Arizona income taxes, you can make a contribution to any of the LHUSD #1 schools and receive a **tax credit of equal value** when you file your tax return? By giving now, you reduce your state income tax liability later! Your tax dollars support extra/co-curricular school programs in Lake Havasu, and **your tax dollars stay in Lake Havasu** instead of going to Phoenix. ***It's a win-win for all of us!***

What is a tax credit?

A tax credit is **NOT** a donation! It **IS** a dollar-for-dollar reduction in the state income tax you pay. If your tax credit contribution is more than the amount of state tax you owe, the credit can be carried forward up to five years. When filing your income taxes for the State of Arizona, the amount you contributed to the school and program of your choice is the amount you may claim as a full state tax credit. This payment is eligible for Arizona state income tax credit as allowed by A.R.S. §43-1089.01. (Tax credit contributions are non-refundable by LHUSD #1)

YOU hold the power to choose how YOUR state income tax dollars are invested!!
